

**THE CORPORATION OF THE CITY OF TEMISKAMING SHORES  
BY-LAW NO. 2008-007  
BEING A BY-LAW TO AMEND BY-LAW NO. 2007-015, A BY-  
LAW TO APPOINT COMMUNITY REPRESENTATIVES TO  
VARIOUS COMMITTEES AND BOARDS FOR 2007, 2008, 2009  
AND 2010.**

**WHEREAS** under Section 8 of the Municipal Act, 2001, S.O. 2001, c.25, as amended, the powers of a municipality shall be interpreted broadly to enable it to govern its affairs as it considers appropriate and to enhance the municipality's ability to respond to municipal issues;

**AND WHEREAS** under Section 9 of the Municipal Act, 2001, S.O. 2001, c.25, as amended, a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under this or any other Act;

**AND WHEREAS** under Section 10 (1) of the Municipal Act, 2001, S.O. 2001, c.25, as amended, a single-tier municipality may provide any service or thing that the municipality considers necessary or desirable for the public;

**AND WHEREAS** the Council of The Corporation of the City of Temiskaming Shores adopted By-law No. 2007-015 appointing community representatives to various committees and boards for 2007, 2008, 2009 and 2010;

**AND WHEREAS** the Council of The Corporation of the City of Temiskaming Shores deems it necessary to amend By-law No. 2007-015;

**NOW THEREFORE** the Council of The Corporation of the City of Temiskaming Shores hereby enacts the following as a by-law:

1. That Schedule "A" to By-law No. 2007-015 listing community representatives to various committees and boards be repealed and replaced with Schedule "A" attached hereto and forming part of this by-law; and
2. That the Clerk of the City of Temiskaming Shores is hereby authorized to make any minor modifications or corrections of an administrative, numerical, grammatical, semantically or descriptive nature or kind to the by-law and schedule as may be deemed necessary after the passage of this by-law.

**READ a FIRST, SECOND and THIRD TIME and FINALLY PASSED** this 12<sup>th</sup> day of February, 2008.
