

  - f) Where an additional dwelling unit is located in a detached accessory building on a lot in the R1, RU, or A1 zone the additional dwelling unit shall be located within the existing developed area of the property in proximity to the principal dwelling;
  - g) The *additional dwelling unit(s)* and main *dwelling unit* shall meet all other applicable provisions of this By-law and any other servicing, fire, health, safety, or occupancy regulations or by-laws;
  - h) A minimum of one parking space is provided for each additional dwelling unit and does not result in a separate driveway being required, except in the case of a lot in the settlement area with access to two public roads, in accordance with the City's Access Control policy;
  - i) Where an additional dwelling unit is located in a detached accessory building, the additional dwelling unit cannot be severed:
  - An additional dwelling unit is not permitted on a lot with partial municipal sewer and water services;
  - k) Where a dwelling unit is already located on a lot within an assessment area subject to an H1, H2, or H3 provision, an additional dwelling unit is permitted in accordance with the provisions of this Section.

Good morning/afternoon,

Ontario is taking action to streamline and modernize its almost 50-year-old environmental assessment process that is too slow, unnecessarily burdensome and costly, to build Ontario while continuing to protect the environment. As part of this plan, we are making practical changes that would ensure strong environmental oversight while reducing delays to get shovels in the ground on projects that matter most to Ontario communities.

Today, on behalf of the Ministry of the Environment, Conservation and Parks, I am writing to let you know that the Municipal Class Environmental Assessment (EA) has been amended as part of the ministry's work on EA modernization.

Over the last three years, our modernization efforts have focused on ensuring strong environmental oversight while reducing delays on infrastructure projects that matter most to Ontario communities. This process includes considering input from stakeholders and Indigenous communities and streamlining requirements for low-risk municipal infrastructure projects, while maintaining strong environmental oversight and protection.

In 2019, the Ministry of the Environment, Conservation and Parks invited the proponents of class environmental assessments to review their assessment process and to propose changes to reduce duplication and better align assessment requirements with risk. We started consulting with municipalities, government agencies and Indigenous communities on the proposed amendments to the Municipal Class EA in 2020. I want to thank all who have offered feedback on the proposed amendments, through submitting comments, participating in webinars and correspondence. We have considered all comments received during the consultation, in addition to conducting our own analysis before the minister decided on the proposed amendments to the Municipal Class EA.

After careful consideration, the decision was made to approve many of the proposed amendments to the Municipal Class EA, including amendments proposed by the ministry. Various changes were made to the Municipal Class EA to update project schedules to better align the level of assessment with the environmental impact of the project. By looking at smarter, more modern ways of doing business, we're making sure important public services and infrastructure projects can get off the ground faster without unnecessary costs and delays.

Amendments to the Municipal Class Environmental Assessment Page 2.

Based on input received from Indigenous communities and Ministry of Citizenship and Multiculturalism (formerly the Ministry of Tourism, Culture and Sport) regarding the need to ensure the protection of archaeological resources and burial sites, an archaeological screening process will be required for various project types that are now eligible for exemption. The exemption will be conditional on the completion and outcome of the screening. The archaeological screening process consists of three questions with links to various tools and criteria developed under the *Ontario Heritage Act*. Proponents must carry out the specified research and consultation to accurately respond to each question, including consultation with Indigenous Communities, municipal governments, and Ministry of Citizenship and Multiculturalism, and may require the assistance of a licensed archaeologist. A project that the screening process applies to would not be exempt unless the archaeological screening process is completed as required, project documentation maintained and all mitigation measures that are identified through the screening process are implemented.

Please see Appendix 1 of the Municipal Class EA for more information on the new archaeological screening process.

The changes are effective as of the date of posting on the Environmental Registry of Ontario, March 3, 2023.

Proponents authorized to proceed with projects through the Municipal Class EA are required to proceed in accordance with the transition provisions set out in the amended Municipal Class EA, as it came into effect on March 3, 2023. Municipalities should review the amended Municipal Class EA to determine the impact on their project.

# Recommendations

It is recommended:

- 1. That Council for the City of Temiskaming Shores acknowledges receipt of Administrative Report CS-011-2023; and
- 2. That Council hereby approves/denies the Application to purchase Municipal Land from Abdul Khaliq for a portion of Dymond Crescent as identified in Appendix 1, conditional on the approval of a Zoning By-Law Amendment application, approval of a Site Plan Agreement; and registration of any easements required by the municipality and applicable external agencies; and further;
- 3. That Council include in the agreement of purchase and sale; a clause stating that ownership will revert to the municipality in the event that an approved development does not proceed within a determined timeframe.

# **Background**

The City received an application from Abdul Khaliq via Knifton Developments to purchase a portion of the roadway known as Dymond Crescent. The Applicant currently owns two parcels of land on either side of the roadway, one on Davidson Street and one on the portion of Dymond Crescent; identified on Appendix 1. The portion of Dymond Crescent being requested to purchase aligns with the property owned along that section of roadway.

A public meeting was held at the February 21, 2023 Regular Council meeting where Council had the opportunity to hear comments relating to the potential disposition from staff and the public. John Knifton of JK Development also provided a brief overview of the proposed housing development for the area.

The Northdale Manor stated that they would be interested in a portion of the lane as well for Emergency Exit purposes. The Northdale Manor also requested information relating

to the proximity of the development to the property line and further what the Developer is planning to do to address the steep grade of land where the development is being proposed.

Barry Waitt, representing residents of the surrounding neighbourhood, requested that more information be made available to the residents in the area relating to the development prior to Council making a final decision on the sale of land, and further inquired whether neighbouring properties would be provided an opportunity to purchase a section of Dymond Crescent to create a buffer.

The presentation also included other written comments that had been received from neighbouring property owners who were not in favour of the land sale or potential development for a variety of reasons relating to privacy, value of their homes and quality of life.

Following the meeting, staff received the following comments from Enbridge Gas:

Enbridge Gas Inc has completed review and we will require an easement prior to the sale of this closure and sale. Also please note that the purchaser must be made aware that we do have a pipeline in this section and must adhere to the easement with regards to structures, etc. (Identified in Appendix 2)

# **Analysis**

Until such time that more information is made available regarding the proposed development; staff are suggesting that Council address the application to purchase municipal land as it was submitted and identified in Appendix 01. If through the Zoning By-law amendment and Site Plan processes it is determined that the entirety of the roadway is required, staff will present Council with further options at that time.

A survey will be required, at the expense of the purchaser, to provide proper delineation of the section of roadway being requested and the portion that would be retained by the Municipality.

An agreement of Purchase and Sale would be presented by By-Law once all the conditions have been satisfied and the development is approved to proceed.



The Tender documents were prepared and Tender PW-RFP-001-2023 was distributed to previous and known potential bidders and advertised on the City's web site, with closing date at 2:00 p.m. on February 23<sup>rd</sup>, 2023.

# Mayor and Council:

City staff continue to move the new Haileybury Fire Hall project towards completion in conjunction with our contractor CGV Builders. Construction is 99% completed and staff are just awaiting signoffs from building officials and engineers before receiving partial occupancy. There are a handful of items which will remain outstanding until the weather improves or the equipment is received but won't affect use of the building while the city begins moving equipment and furniture into the building.

Since the last update provided to council at the February 7, 2023, Regular Council Meeting, City staff have approved one (1) change order totalling \$12,705 plus non-recoverable HST.

CCO#13 was for \$12,705 and will see additional snow and ice guards installed on the west side of the building. This will provide additional protection from falling snow and ice and decrease the amount of staff time required to clear snow from that side of the building.

This contract change order was less than 5% of the total contract cost and within the approval authority of staff.



Council for the City of Temiskaming Shores received administrative report RS-004-2022 at the March 1, 2022 Regular Council meeting. That report outlined a proposed agreement between Zubyck SkillZ Ltd and the City for use of the Shelley Herbert Shea Memorial Arena dry floor. Council subsequently passed the following resolution:

Be it resolved that Council for the City of Temiskaming Shores acknowledges receipt of Administrative Report No. RS-004-2022; and

That Council directs staff to prepare the necessary by-law to enter into a lease agreement with Zubyck SkillZ Ltd. for the use of the Shelley Herbert-Shea Memorial Arena Dry Floor from May 1, 2022 to July 17, 2022, for consideration at the March 1, 2022 Regular Council meeting.

Zubyck Skillz Ltd utilized the Shelley Herbert-Shea Memorial Arena Floor from May 1, 2022 until June 17, 2022 as outlined within the agreement. Staff noted that there were no issues reported with their usage of the facility, and they successfully hosted numerous sport programs for local youth.



Zubyck Skillz, connected with City staff in February 2023 to discuss their interest in a renewed usage agreement for the Shelley Herbert-Shea Memorial Arena for 2023.

# <u>Analysis</u>

Analysis from previous years shows that, prior to use by Zubyck SkillZ, the Shelley Herbert-Shea Memorial Arena had been underutilized in the summer months.

Staff reviewed the proposed agreement with SkillZ and are confident that the agreement will bring a net positive value to the City. The facility will be used to provide various youth sports training opportunities which will bring increased traffic to this area of the community during the summer months. This will be another opportunity for local youths to participate in sport and recreation activities within the city.

Within the lease agreement is the option for a one (1) year extension of the lease with a 2% annual increase in payment to the City.

# **Background**

The City of Temiskaming Shores adopted the terms of reference for the Bicycle Friendly Community Committee at its regular meeting on June 7, 2016. The committee's purpose was to:

- 1. Advise Council on matters of a Bicycle Friendly Community including engineering, education, encouragement, enforcement, evaluation and planning, and assist Council in carrying out its bicycle friendly community program.
- 2. Act as a liaison between Council and the community with respect to all aspects of a bicycle friendly community within the municipality, including input in Recreation planning.
- 3. Provide the community with a resource and instrument for the development and implementation of a Bicycle Friendly Community
- 4. Promote awareness, education and participation in cycling.

Since 2016 the committee has been meeting on its regular schedule to move these objectives forward. Some of the committee's accomplishments include:



- 1. Award recipient of Share the Road's Bicycle Friendly Community bronze designation (2016 and 2020)
- 2. Creation of a comprehensive community cycling routes guide
- 3. The implementation of a comprehensive active travel data collection program
- 4. Collaboration in the City's 2020 Recreation Master Plan
- 5. Partnership collaboration in the City's 2021 Active Transportation Plan
- 6. Creation of a free community bicycle exchange

Within the Active Transportation Plan, it was recommended that the scope of the Bicycle Friendly Committee be expanded to include all forms of active travel.

One of the recommendations contained in this plan is to expand the mandate of the BFC Committee to encompass all areas of Active Transportation.

Active Transportation Plan, Page 89

To coincide with the new term of council, a new terms of reference was drafted for an Active Travel Committee which would be tasked with the same purpose as the Bicycle Friendly Committee while also being given a mandate to advocate for all modes of active transportation.

# **Analysis**

The proposed terms of reference are similar to those passed in By-Law 2016-105 regarding scope of the committee and its mandate. They have been updated to ensure the committee will consider all aspects of active travel within their discussions and advocacy.

The City placed an open call to the public for applications to sit on the Active Travel Committee in November 2022. A total of seven (7) members of the public were appointed to the committee by Council for its 2022-2026 term at the December 20, 2023 Regular Council meeting.

# **Background**

The scoreboard at the Don Shepherdson Memorial Arena is in the arena bowl on the east wall of the facility. The scoreboard is placed in a position such that it is not visible or only partially visible to people who sit at that end of the facility. The scoreboard was purchased in 2005 but still meets the needs of facility users. Staff have identified the scoreboard controller as a piece of equipment that should be proactively replaced as it is an essential component of the facility and showing signs of advanced wear and tear.

At the Don Shepherdson Memorial Arena, the City of Temiskaming Shores sells board advertisements to local businesses and organizations. At the beginning of 2023 staff began proactively selling these spaces and have increased the number of advertisements from 29 to 40. At the Shelley Herbert-Shea Memorial Arena the number of advertisements has increased from 7 to 12.

Brownlee Equipment contacted the City of Temiskaming Shores in February 2023 requesting to place a board ad in both the Don Shepherdson Memorial Arena and the Shelley Herbert-Shea Memorial Arena. With the increase in the number of board ads at the DSMA, there are only two spaces available, neither of which are in a desirable location. As such, staff proposed that Brownlee Equipment purchase an ad that would be placed on the wall of the west end of the facility, at an increased rate. The City would



then purchase an auxiliary scoreboard which would be placed on the same wall next to their advertisement.

# <u>Analysis</u>

This new auxiliary scoreboard would be used in conjunction with our current scoreboard and serve two purposes. It would provide an enhanced experience for patrons of the Don Shepherdson Memorial Arena and further cement its position as a destination arena for large scale events such as NOHA and OHF Championships. Secondly it would also serve as a backup scoreboard which could be used individually if our current scoreboard were to suffer a problem which left it inoperable for any period of time.

The proposed advertisement fee for Brownlee Equipment would not only cover the purchase cost of the new scoreboard but also provide an ongoing fee for their advertisement over the course of the term of the agreement.

The proposed advertisement spot is on the west wall, above the hall windows. The flags currently in this space would be moved higher with the scoreboard and advertisement installed below them. This space is currently underutilized and can instead be used to help enhance the facility.

As part of the agreement, the City of Temiskaming Shores will complete the installation of the advertisement and scoreboard. This would take place this summer during regularly planned maintenance. Brownlee Equipment would be responsible for the cost of the advertisement and any costs for future changes to their advertisement.

Box 2050, Haileybury, ON P0J 1K0) fax (705-672-2911) or email <a href="mailto:finance@temiskamingshores.ca">finance@temiskamingshores.ca</a> at first opportunity in order to be reconciled with invoices without delay.

The fuel delivered and dispensed to City tanks shall be metered and the meters shall be certified correct within normal tolerances approved by the Ministry of Consumer and Commercial Relations.

# 4. Emergency Delivery Response

The City shall require fuel delivery to the Emergency Operations Centres (EOC's) and also to the sanitary pumping stations when requested. In the event of a community emergency, i.e., fire, widespread power failure, severe weather, severe flooding, etc., the Providers first priority shall be to mobilize fuel deliveries to the EOC's and pumping stations on short notice, and to connect with the City Representative in order to strategize/minimize the impact of the emergency to the public. The critical emergency sites shall be required to be continuously operational.

#### 5. Contract Extension

The term of this contract may be extended for an additional two year period with all terms and conditions remaining the same provided that both the City and the Supplier agree to such extension in writing.

# 6. Safety

While delivering on City property, The Provider's attention is drawn to the provisions of the Occupational Health & Safety Act 2010. The Supplier shall be considered the "Constructor" under the terms and conditions of this agreement. Certificates of good standing from the Workplace Safety & Insurance Board will be required before commencement of work and before final payment is made.

If at any time during the duration of the contract either the equipment or personnel are operating in an unsafe manner, the City's Director or his designate shall have the right to suspend the operation and have the equipment and the operator removed from the delivery site.

The Supplier shall report promptly to the City's Transportation Supervisor, giving full details in writing of all accidents in connection with the performance of the work, which results in property damage, death or injury.

#### 7. Insurance

While delivering on City property, the Supplier shall carry motor vehicle liability insurance having limits of not less than \$5,000,000 inclusive per occurrence for bodily injury, death and damage to property. The Provider shall provide proof of general liability insurance having limits of not less than \$5,000.000 inclusive per occurrence for bodily injury, death and damage to property and including the City as an additional insured and containing a cross liability clause.

#### 8. Quantities/ Locations

The Municipality makes no guarantee as to exact locations nor litres and therefore reserves the right to revise locations and actual litres as the situation warrants and payment will be made for actual litres delivered.

# 9. Specifications

All goods supplied to the City must be appropriately identified as approved by the Canadian Standards Association (CSA) and/or the Underwriters Laboratories (UL), standards for safety.

# 10. Special Provisions

The fuel products shall meet and/or exceed these and /or the latest revisions to Canadian regulations.

- Regular Unleaded Gasoline CAN/CGSB-3.5-99:
- Regular Ethanol Gas Canadian Environmental Protection Act Standard ECP-16-90, Section 8 (1) (b);
- Low Sulphur Clear Diesel CAN/CGSB 3.6-2000, Sulphur max 0.05 wt %;
- Regular Coloured Diesel CAN2-3.2-M89 Type 2, known as No. 2 Diesel Fuel.

All fuels shall meet all Federal and Provincial Regulations including sulphur reductions, sulphur in gasoline not to exceed 150 P.P.M. as at December 31, 2004 and further reduced to 30 P.P.M. thereafter, AND sulphur in diesel not to exceed 500 P.P.M. and further reduced to 15 P.P.M. by June 2006. Witnesses that in consideration of the rents reserved and the covenants and provisos herein contained on the part of the Tenant, the Landlord hereby leases to the Tenant those certain Lands situated in the City of Temiskaming Shores, in the District of Timiskaming, being the Shelley Herbert-Shea Memorial Arena Hall, hereinafter referred to as the "Lands". To hold the Lands for a term commencing on the 8th day of April 2023 and ending on the 30th day of June 2023. The rent in respect of the Lands shall be the sum of \$2,550 + HST, payable on the April 8th, 2023. Rental payments shall be made to The Corporation of the City of Temiskaming Shores, or as otherwise directed by the Landlord.

It is acknowledged by both parties that the Lands are limited to the following areas: main arena floor surface, arena viewing stands, change rooms, washrooms, and lobby having an entrance off of Ferguson Ave. (hereinafter referred to as "the Premises")

### **Section One - Tenant's Covenants:**

The Tenant covenants with the Landlord as follows;

- (a) **To pay rent** to pay rent in the amount of \$2,550.00 plus HST; payable April 8, 2023.
- (b) **Term** The term of the agreement shall be from April 8th, 2023, to June 30th, 2023.
- (c) **Compliance with by-laws** to comply with and conform to the requirements of every applicable statute, law, by-law, regulation, requirement and order from time to time in force during the term of this agreement, and any extension thereof, affecting the condition, maintenance, use or occupation of the Lands or the Premises; and in so doing the Tenant shall make the necessary alterations, repair, or addition to or deletion from any part of the Premises or any equipment or other facility used in connection with or appurtenant to the Lands provided that the use of any part of the Lands as a non-conforming use under the applicable zoning by-law is not a violation of the provisions of this paragraph.
- (d) **Maintenance and Repairs** to repair, reasonable wear and tear and damage by fire, lightning and good repair, reasonable wear and tear and damage by fire,

lightning and tempest only excepted; and to permit the Landlord to enter and view the state of repair and to repair according to notice in writing, reasonable wear and tear and damage by fire, lightning and tempest only excepted. and to leave the premises in good repair, reasonable wear and tear and damage by fire, lightning and tempest only excepted.

- (e) **Waste** not to suffer any waste or injury to the Premises, or any part thereof, and not to use or occupy the Premises, or any part thereof, or permit them to be used or occupied for an unlawful purpose.
- (f) **Insurance** not to use the Premises or permit items to be used for any purpose which may render the insurance on the Premises void and if the rate of insurance is increased as a result of anything done upon the Lands by the Tenant, the Tenant will pay to the Landlord as additional rent the amount by which the insurance premiums are so increased. In addition, and in any event, the Tenant, shall during the term of the lease and any renewals, at its sole costs and expense, keep in full force and effect, in the names of the Landlord and the Tenant, public liability insurance applying to all operations of the Tenant, which include bodily injury liability and property damage liability. Such policy or policies shall be for not less than \$5,000,000.00 per occurrence. The Tenant shall produce to the Landlord a Certificate of Insurance confirming the above coverage prior to taking control of the Premises.
- (g) Alterations, new structures except as herein provided, not to make or permit to be made any structural alteration, addition, change or improvement to the Premises without obtaining the prior written approval of the Landlord, which approval shall not be unreasonably withheld provided the Tenant has fully complied with the terms, covenants and conditions of the lease.
- (h) Replacement of damaged Premises in the event that the complete destruction of or damage to the Premises, or partial damage to the Premises, results in the Tenant's inability to reasonably carry on his business therein the Tenant is permitted to terminate this lease by providing notice to the Landlord within fifteen (15) days of the happening of the damage or destruction. If the Tenant chooses not to terminate the lease within fifteen (15) days from the damage or destruction, the Landlord shall begin the repair or replacement thereof and with due diligence, repair or reconstruct the Premises or replace the Premises with another Premises of the same type and character and of equal value. After completing the repair, reconstruction or replacement, the balance of any insurance proceeds or other proceeds available by reason thereof belong absolutely to the Landlord.
- (i) **View state of repair -** to permit the Landlord at all reasonable times to enter and view the state of repair of the Premises.
- (j) Indemnity to indemnify and save harmless the Landlord against and from any and all claims by or on behalf of any person or persons, firm or firms, or corporation or corporations arising from the conduct or any work, by or through any act of

negligence of the Tenant or any assignee, subtenant, agent, contractor, servants, employee or licensee of the Tenant;

- (k) **Nuisance** not to do or permit a nuisance.
- (I) **Assignment** not to sublet the Lands or any part thereof.
- (m) Use of Premises not to permit the Premises to be used for any purpose other than to carry on the business of a Multi Sports Youth Program and not to carry on or permit to be carried on therein any other trade or business without the consent in writing of the Landlord.
- (n) **Name of Premises** not to name the Premises or permit it to be named without the consent of the Landlord; such approval shall not be unreasonable withheld.
- (o) Signs not to use the outer walls or windows of the Premises for any notice or name plate except as approved by the Landlord; such approval shall not be unreasonable withheld.

#### Section Two - Landlord's Covenants

The Landlord covenants with the Tenant as follows:

- a) Quiet enjoyment for the quiet enjoyment.
- b) **Taxes** to pay all property taxes and rates that may be levied against the Premises.
- c) **Electricity and Water** to pay for the electricity supplied to the premises and any water/sewer charges levied against the Premises.
- d) Heat to heat the Premises.
- e) **Insurance** The Landlord shall maintain adequate fire and other perils insurance coverage on the Premises.

  - (v) The Tenant fails to perform or observe any of the covenants, agreements or provisions, conditions or provisos contained in this lease on the part of the Tenant (other than the payment of rent or other sums of money) and the failure continues for, or is not remedied within thirty (30) days next after the giving of written notice by the Landlord to the Tenant, or if the term hereby granted is taken in execution or attachment, it is lawful for the Landlord to enter upon the Premises or any part thereof in the name of the whole and this shall be at the option of the Landlord and with or without entry may terminate the lease and all the rights of the Tenant with respect to the Lands shall be absolutely forfeited. If the condition complained of reasonably requires more time to cure than the thirty-day period aforesaid, the Tenant is deemed to have complied with the remedying thereof if the Tenant has commenced remedying or curing the condition within the thirty-day period and diligently thereafter completes the same. Upon termination of the lease, the Landlord shall not disturb the possession of any subtenant of the Premises pursuant to a sublease, or an agreement to sublease, as long as the subtenant is not in default in the

- (e) Force Majeure Neither the Tenant or Landlord shall be held responsible for delays in the performance of its obligations hereunder when caused by a declared state of emergency, public health emergency, pandemic or epidemic (including, but not limited to, the COVID-19 pandemic); government mandated closures; the closure of government buildings, airports, harbors, railroads, or pipelines, or other infrastructure due to a public health emergency, pandemic or epidemic; industry wide strikes, lockouts or labor disputes; acts of God; inability to obtain labor or materials or reasonable substitutes therefor that could not reasonably have been anticipated; governmental restrictions, regulations or controls; delay in issuance of permits beyond time periods typical for the jurisdiction in which the Building is located; enemy or hostile governmental action; civil commotion; fire or other casualty; and other causes beyond the reasonable control of such party (each, a "Force Majeure Event"), provided that a Force Majeure Event and the ongoing effects thereof shall not excuse any failure of Tenant to timely comply with any monetary obligations hereunder.
- (f) Rent Abatement If a Force Majeure Event occurs during the Term of this Lease which reasonably precludes Tenant from constructing, renovating, opening or operating the permitted use at the Premises and the Tenant ceases such operation in the Premises, then Rent shall abate for the period commencing on the later of (a) the date on which such Force Majeure Event occurs or (b) the date on which Tenant ceases operation of the permitted use at the Premises, and ending on the earlier of (c) the date on which such Force Majeure Event concludes or (d) Tenant resumes operating the Permitted Use at the Premises.
- (g) **Right of Renewal** The Tenant shall have the right, if not otherwise in default, of renewing the lease for a one (1) year term (2024). The use of the Premises shall be agreed upon by the Tenant and the Landlord. The rent amount to be increased by 2%. All other terms and conditions to remain the same. The Tenant shall be required to give written notice of their intention to renew the lease on or before the 31st day of December prior to the commencement of the renewal term;
- (h) Right of termination by the Landlord The Landlord shall have the right to terminate this lease forthwith by leaving upon the premises, or sent by ordinary mail to his usual place of business, thirty (30) days' notice in writing of its intention, and thereupon any payments owing to the Tenant under this lease shall be computed, apportioned and paid in full to the date of such termination, and the Tenant shall immediately deliver up possession of the Premises to the Landlord, and the Landlord may re-enter and take possession of the Premises.

- (I) **Binding Effect** The terms and provisions of this lease extend to, are binding upon and ensure to the benefit of the parties, their successors and assigns and shall be interpreted according to the laws of the Province of Ontario.
- (m)**Captions** The captions appearing at the headings of the paragraphs in this lease have been inserted as a matter of convenience and for reference only and in no way define, limit or enlarge the scope of meaning of this lease or any of its provisions.

# City of Temiskaming Shores Active Travel Committee Terms of Reference

### 1. Background

A municipal Council may by by-law and in accordance with the Procedural By-law of Council, establish an Active Travel Committee.

In December 2021, the city adopted the Active Transportation Plan, building on previous municipal planning documents and in response to the increase in support for active transportation and recreation in the city.

In establishing an Active Travel Committee, Council recognizes the importance of cycling, walking and wheeling and as an indicator of a healthy, vibrant and active community and is based on the essential elements set out in the Active Travel Plan.

### 2. Vision & Mission Statement

#### 2.1. Vision<sup>1</sup>

Active Transportation in Temiskaming Shores will be safe and accessible and contribute to a healthy, sustainable, and supportive community where people of all ages and abilities can participate.

#### 2.2. Mission

The City of Temiskaming Shores Active Travel Committee will aspire to create a great place for human powered travel. Temiskaming Shores' culture of outdoor activity and recreation will be extended to include walking, cycling and wheeling through the community, with community members feeling increasingly comfortable exploring Temiskaming Shores' natural assets and urban environments by human powered travel.

### 3. Definitions

"City" The Corporation of the City of Temiskaming Shores

"Committee" The Active Travel Committee

"Council" The Council of the City of Temiskaming Shores

"Municipality" The land within the geographic limits of the City of Temiskaming

Shores

"Pecuniary interest" A direct or indirect interest within the meaning of the municipal

Conflict of Interest Act, R.S.O, 1990, chaper M.50, as amended, and

any subsequent legislation thereto.

"Timely manner" within fifteen (15) business days, excluding holidays

### 4. Accountability

4.1. The Temiskaming Shores Active Travel Committee is deemed a Committee of Council and except where prescribed herein functions in accordance with the provisions set out in the City of Temiskaming Shores Procedural By-law No. 2023-022.

### 5. Membership

- 5.1. Two members of Council will be appointed by Council to the Active Travel Committee in accordance to the City of Temiskaming Shores' Procedural Bylaw No. 2023-022. The Mayor may sit as an ex officio member.
- 5.2. As a Committee of Council, the Active Travel Committee is subject to the Procedural By-law, unless otherwise specified in this Terms of Reference.
- 5.3. The Committee will be appointed by Council and shall consist of a minimum of three (3) voting members of the public and may include up to seven (7) voting members of the public.
- 5.4. Quorum of the Active Travel Committee will be 50% + 1 of the members appointed to the Committee.
- 5.5. Members of the Active Travel Committee shall serve at the pleasure of Council without remuneration.

- 5.6. When appointing members Council shall take into consideration an applicant's special expertise, experience, and commitment to promoting and facilitating active transportation.
- 5.7. A Committee member shall hold office for a term concurrently with the term of the appointing Council, or until successors are appointed, and may be appointed for one or more further terms.
- 5.8. The City shall advertise for Committee Members at the beginning of each new Term of Council and on an as needed basis throughout the term.

### 6. Meetings

- 6.1. The Active Travel Committee will meet a minimum of three times per year.
- 6.2. Unless otherwise determined, all meetings will be open to the public.
- 6.3. A Chair will be elected by the members at the first annual meeting of the committee.
- 6.4. The City will assign a staff person who shall act as Secretary to the Committee and be responsible for the preparation and distribution of agenda and minutes, retention of files and records and as a resource for information gathering for the Committee. The agendas will be prepared by staff along in consultation with the Chair, with input from other members.
- 6.5. Any person(s) wishing to appear before the committee as a delegate must submit a request to the committee secretary advising of the topic or item to which they wish to speak.
- 6.6. Every member present (including the Chairperson) when a question is put, shall vote thereon unless they are disqualified to vote on the question. (i.e. declared pecuniary interest). Recommendations are "carried" if supported by majority. Only resolutions as they appear in the adopted minutes may be considered as officially representing the position of the committee.

### 7. Conduct of Members

- 7.1. No member, individually or as a group, shall provide comment, opinion or make representation of any kind to any person or group with respect to any matter or thing relating to the function of the Active Travel Committee or Council unless authorized to do so by a resolution of the Active Travel Committee or Council.
- 7.2. Should a member knowingly violate City policies or conducts themselves in a manner deleterious to the achievement of the mandate and vision of the Active Travel Committee in respect to their membership on the Active Travel

- Committee, which results in, or has the potential to result in liability/exposure to the City, Council may repeal the appointment.
- 7.3. No member shall make any commitments, financial or otherwise, in respect of the City or the Active Travel Committee or in any manner enter into any form of agreement or receive other inducements or benefits either individually or as a group with respect of their membership on the Active Travel Committee.
- 7.4. Where applicable, members shall declare a conflict of pecuniary interest and shall at all times conform with the requirements of the City of Temiskaming Shores Procedural By-law No. 2023-022.
- 7.5. Should a member fail to participate in three (3) consecutive regular meetings, or more than 50% of all regular meetings of the Committee in any calendar year exclusive of a granted leave of absence, Council may repeal the appointment.
- 7.6. Should a member request a leave of absence from the Committee, such request shall not exceed six (6) months in length and shall be made to Council through the committee.

### 8. Reporting and Monitoring

8.1. The Active Travel Committee will provide Council with minutes of meetings and report on specific matters as necessary. Once approved, these minutes will be posted on the City's website.

### 9. Objectives

- 9.1. The Objectives of the Temiskaming Shores Active Travel Committee are to:
- 9.2. Advise Council on matters of Active Travel within the community including engineering, education, encouragement, enforcement, evaluation, and planning, and assist Council in implementing the Active Transportation Plan.
- 9.3. Act as a liaison between Council and the community with respect to all aspects of Active Travel within the municipality, including input in recreation and transportation planning.
- 9.4. Provide the community with a resource and instrument for the development and implementation of an Active Travel Community.
- 9.5. Promote awareness, education, and participation in Active Travel.

### 10. Roles and Responsibilities

- 10.1. The Committee will act in an advisory capacity to Council in matters pertaining to Active Travel and will cooperate with other governmental agencies and civic groups in the advancement of sound cycling and walking infrastructure and programs.
- 10.2. Make recommendations to Council regarding:
  - 10.2.1. Active travel infrastructure that may exist or may be needed.
  - 10.2.2. Active travel programming that may exist or may be needed.
  - 10.2.3. The coordination of active travel infrastructure and programs with the programs of other agencies and voluntary organizations so as to ensure the most effective use is being made of community resources.
  - 10.2.4. Other active travel issues as referred to by staff
- 10.3. Community Involvement and Liaison with Community
  - 10.3.1. Develop and maintain a liaison with community groups and individuals within the municipality, District, Province, and at the Federal level, that share the objectives of the Committee in order to foster their joint objectives.
- 10.4. Information and Education
  - 10.4.1. Educate the community to encourage an active and healthy community
  - 10.4.2. Educate the community as to the role and function of the Active Travel Committee.
  - 10.4.3. Develop partnerships with the community and private sector for activities and projects that raise awareness, educate and inform the public of the benefits of Active Travel in terms of personal health and wellness, strengthening communities through social interaction, volunteerism, civic pride and aesthetics, safe communities, and community leadership.
