### Accomplishments & Highlights

### Creation and distribution of the Community Guide

The "Community Services for Older Adults" guide was developed highlighting services available to older adults in Temiskaming Shores & Area. Copies have been distributed through community partners and is available online in both French & English. Provincial funding has been approved to update the guide that will be developed, printed and redistributed in 2021.

#### Developed 1-800 number for transportation

Developed and promoted a 1-800 number as a single call for those 60 and over who require transportation. Timiskaming Home Support assists in finding appropriate transportation locally and out-of-town.





#### Free Transportation

Free transit was offered in October 2019 for the Federal Election provided by Age Friendly. The Age Friendly Committee brainstormed ideas for improvements and items to be addressed to the Temiskaming Transit Committee in February 2020.

#### Travel training

Travel training was held in the fall of 2019 to promote and educate on the bus route of the transit system. Training occurs once a year in the fall.

#### Palliative care suite opens at the Temiskaming Hospital

#### Get Active Program is now municipally funded

Expansion and growth of local activities include pickleball, indoor walking at Ecole Catholique Secondaire Sainte-Marie in New Liskeard and at Northern College in Haileybury and line dancing.

#### Benches installed in identified areas

Installation of 3 benches in the downtown core of New Liskeard/North Cobalt/Haileybury.





#### Communication enhancements

Distribution of the "Community Services for Older Adults" guide to ensure older adults have access to information required. Monthly Coffee Hours serve as a means of connecting local older adults with local services providers in informal settings. There has also been an effort to use social media as a platform for disseminating current information to the community at large as well as a monthly newsletter.

### **Eight Focus Areas of Age-Friendly Communities**

According to the World Health Organization (WHO), an age-friendly City has both the physical and social structures in place to allow older adults to maintain a high quality of life. The WHO developed 8 categories to be considered when looking at creating an Age Friendly community. The "Age Friendly Community Plan" for the City of Temiskaming Shores and Area reflects the specific opportunities of the community regarding the following 8 categories. Officially becoming a WHO member as an age-friendly City in the spring of 2019. A Recreation Master Plan was conducted in 2020 with a research consultant company to study what is needed and wanted in the community; the study will assist with applying for funding and the direction the community hopes to go to with recreation benefiting everyone in the community.

### **Timeframes**

The Timeframes" identified in the plan are separated into 3 categories, best representing the time frame expected to achieve the "Action Item" outlined.

"Short Term" indicates 1-3 years;

"Medium Term" indicates 3-7 years and;

"Long Term" indicates 7-10 years
