THE CORPORATION OF THE CITY OF TEMISKAMING SHORES BY-LAW NO. 2012-156

BEING A BY-LAW TO AMEND BY-LAW NO. 2011-138, A BY-LAW TO REGULATE AND CONTROL OPEN AIR BURNING WITHIN THE CITY OF TEMISKAMING SHORES.

WHEREAS Council adopted By-law No. 2011-138 on October 18, 2011 to regulate and control Open Air Burning within the City of Temiskaming Shores;

AND WHEREAS at its November 6, 2012 meeting, Council acknowledged receipt of Administrative Report No. PPP-010-2012 proposing amendments to the Burning Bylaw and directed staff to prepare the necessary by-law to adopt the amendments to By-law No. 2011-138 as approved by Council at the said meeting;

NOW THEREFORE the Council of The Corporation of the City of Temiskaming Shores hereby enacts as follows:

- 1. That Council approves the following amendments to Schedule "A" of By-law No. 2011-138:
 - Correction to Page 2 of Schedule "A" to By-law No. 2011-138 Index:
 3.6 MNR Fire Restricted Zones/City of Temiskaming Shores Fire Ban;
 - Correction to Page 6 of Schedule "A" to By-law No. 2011-138 Regulations Section 3.2 to read as follows:
 - 3.2 No *person* shall conduct an *open air burn* at any time other than the *owner* of the property where the fire is to occur, save an authorized agent acting on the *owner(s)* behalf who produces written authorization signed and dated by the *owner*.
