## Terms of Reference – Barrier

The Members of the Accessibility Advisory Committee agree with the definition of "Barrier" read to the members by Chair Stone which Betty will be using while speaking to Council at their next meeting.

"Barrier refers to anything that prevents a person with a disability from fully participating in all aspects of society because of their disability. This encompasses; physical barriers, architectural barriers, information or communication barriers, attitudinal barriers, technological barriers, or policies, procedures, practices that violate the principles of independence, dignity, integration (inclusion) and equality of opportunity as mandated by the Accessibility Standards of Customer Service Ontario Regulation 429/07."
